Dear Parents and/or Guardians,

The Senior Class of 2017 has been given permission to go to Disney World for their Senior Trip. The trip is scheduled for Monday, March 27th through Friday, March 31st, 2017. The cost of the trip is \$1290. This includes airfare, room, meal debit cards, busing, admission to the park and a senior trip t-shirt. Students will need extra money should they wish to buy extra food, snacks and souvenirs. Students can make their initial deposit of \$430 beginning **May 9th**. Deposits should be brought to my office before June 16th, the last day of school. After June 16th and throughout the summer, students may submit their deposit to Mrs. Sue Clune in the general office. The initial deposit will reserve a spot on the trip for your son or daughter. The second payment (\$430) will be due in September/October and the final payment (\$430) will be due in November.

The following is the payment schedule:

May 9 - August 31 \$430

Sept. 6 - Oct. 7 \$430

Oct.17 – Dec. 1 \$430 If this payment is not made on time, there will be a \$5.00/week late fee starting on Monday, December 5.

PLEASE NOTE: Late fees are to ensure payments are received on time so that the travel agency can be paid its installments on time.

Cash, checks and money orders will be accepted. Checks and money orders are to be made out to the **Audubon Board of Education**, and your child's name should be written on the memo line.

The final day that a senior can sign up for the trip is Friday, October 7th. After this date the travel agency cannot assure a seat on the plane.

Participating seniors will need a **PHOTO ID** to get on the plane. The only forms of ID currently accepted by the airlines are: **A VALID NEW JERSEY DRIVER'S LICENSE, VALID NEW JERSEY PHOTO ID OR A PASSPORT**. A copy of the photo ID must be submitted along with the final payment.

I strongly recommend taking out trip cancellation insurance if your child participates in an extracurricular activity that may conflict with the trip. All trip insurance must be purchased by October 8, 2016.
