- 3. Free medical clinics for adults and children are available for immunizations. There is a location in Bellmawr at the library on Browning Road that is underutilized.

All the services and contact information will be emailed to the Borough Administrator, Commissioners and Municipal Clerk to be able to provide additional information for our residents. He encouraged us to reach out for any human services related needs. Future possible hosting opportunities for local towns were discussed as well. All information is on their website.

COMMISSIONER COMMENTS:

She is now eleven months old and has already been working to assist our officers as well as assisting other local towns. MAYOR JAKUBOWSKI: Thursday, March 30, 2023, Sustainable Audubon is hosting an event at the Audubon Senior Center "Let's Talk Trees" to learn more about the value of shade trees in our community.

Audubon Day is Saturday, April 29, at the FJW Recreation and Community Center. The Borough will be once again be working with the County to provide free shuttle services for our senior citizens. They can park or walk to the Municipal Building at 606 W. Nicholson Road and the shuttles will be moving every half hour to and from the Municipal Building and the FJW Rec and Com Center from 10:00 am to 3:00 pm.

Volunteers are needed for Audubon Day. The Audubon Celebration Committee has been working very hard in the planning. He encouraged all residents to reach out and volunteer.

Bellmawr will be ready shortly after Audubon Day to work on the trail and courts.
