Per Dave Taraschi, the month of October is the target date for resurfacing, but the meetings in September will solidify the details. Percentage of trench restoration is still in question.

**COMMISSIONER WHITMAN:** Reminder all tax bills have been given a grace period until the 18<sup>th</sup> of August. If payments are received after the 18<sup>th</sup>, the interest that is charged goes back to the 1<sup>st</sup> of the month. Two more fire department volunteers are good news as they continue to build up the fire department.

#### **OPEN SESSION:**

Commissioner Whitman made a motion to open the meeting to the public, seconded by Commissioner Lee. All in favormotion carried.

John Poliero, 47 Beloit Ave, expressed concerns with his neighbor. He came to the meeting to ask for the police report that was taken during the most recent incident with his neighbor to be amended. The incident involved tree branches being placed on his property and he in turn returning them back to the neighbor and upsetting the neighbor as she was having a birthday party that day. He has concerns about being watched while cutting his lawn as well. Commissioner Lee suggested that Mr. Poliero contact the police department directly regarding his concerns with the police report as this was not the forum for handling such a request.

Mr. Poliero then expressed concerns about paving and his nice, curved driveway where he could get his car in and out. He claims he was told that the apron is illegal from the sidewalk to the street. He stated that apron on his property now catches all the debris from other neighbors. He is worried that the construction will make it higher and stated that five

Taraschi, the road will be put back in the same elevation as it is now. It will be milled as well. Per Com. Lee, he has the upmost confidence that Public Works will look at it and Dave Taraschi will see to it that it is taken care of appropriately. Per Dave Taraschi, the apron will not be touched by the utility company. They will mill and pave and Dave will take a look at the apron concerns.

Commissioner Whitman made a motion to close the meeting to the public, seconded by Commissioner Lee. All in favor-motion carried.

Commissioner Whitman made a motion to adjourn, seconded by Commissioner Lee.
